Customers of Centro Mobili Giardino has the right to withdraw from the contract within 14 days, from the date of receipt of the goods by the consumer.

The right of withdrawal is free: its exercise is not subject to payment of any sum of money or penalties. The consumer only supports the direct cost of returning the goods. It is also entirely discretionary and unquestionable, it does not require a good cause: the art. 52 of the Consumer Code expressly provides that the consumer may terminate the contract "without having to provide any motivation".

The right of withdrawal is exercised by sending a written communication to Centro Mobili Giardino S.a.s. within the specified time. The consumer, if you wish, can also use the example form, available at the bottom of the General Conditions of Sale (Annex),

Once exercised the right of withdrawal remains to the consumer to send back to the supplier the goods received, as specified below.

The costs of returning the goods shall be borne by the consumer, who is obliged to return at your own expense to Centro Mobili Giardino S.a.s. within 14 days from the exercise of the right of withdrawal. The essential integrity of the property to be returned is an essential condition for the exercise of the right of withdrawal. However, it is enough that the goods are returned in normal condition, having been kept and used with the use of reasonable diligence. In our country, the return costs is between € 35.00 and € 75.00 for cubic meter depending on the locality. Islands have a special quote.

Centro Mobili Giardino S.a.s. will refund the customer the full amount paid for the product by following the transfer of the amount by bank transfer or PayPal. The buyer shall provide promptly to the bank or Paypal account details for the refund. Refund will be made on the business day after the date on which such information will be provided, in any case conditional on receipt of the goods in our warehouses and after the verify of the perfect conditions.

In the event that the procedures and time limits for the exercise of withdrawal rights have not been respected by the consumer, Centro Mobili Giardino S.a.s. is not required to repay any amount. You can still return the good at the expense of the consumer.
